Need 3 year old Nursery School Place?

DON'T WAIT!

Don't wait until your child is 3 years old to start Nursery School. You can register your child when they are 2 years Old.

Will I qualify for 15 hours?



All 3 to 4-year-olds in England can get free early education or childcare.

We also offer Breakfast club

Breakfast Club is open from 8.00 am every day, Places have to be booked in advance and the daily charge for this session is currently £4.00 a day.

We also offer Tea Clubs

After School Childcare/Tea Clubs
Run from 12pm - 6pm. Tea is provided by Chartwells who run the school kitchen and included in the charge.

You just need to contact us to book your Registration Appointment, which are normally held every Wednesday in the afternoon, duration 20 minutes.

You will need to bring your child, their birth certificate or their passport, your National Insurance number and proof of address. A teacher will greet you, help you complete our registration form, answer any of your questions and provide you with a tour of our Nursery School.

Are you the parent or carer of a three year old? Then You may be eligible for 30 hrs Education Funding



Will I qualify for 30 hours?

□ If you earn more than the equivalent of 16 hours at the minimum wage a week, eg £125 a week if you are over 25 - there is no requirement to work 16 hours - the entitlement is about how much you earn, for example you could work 10 hours at £12 an hour. There is a full list of criteria eligibility on the Government Web site.

What if I have Zero Hours Contract or Self Employed?

You will be expected to meet the above criteria for the past 3 months, HMRC will look at data such as your previous earning to consider whether you are likely to be entitled □ You will need to provide a Unique Tax Reference (UTR) number to HMRC so that they can check your previous income. If you are on Maternity Leave: □ It is up to the HMRC to determine your eligibility.

You will NOT be entitled to the 30 hours if

- If you have an income of more than £100,000
- If one or both parents is a non-EEA national

You will need to resubmit every 3 months

You will need to resubmit your original HMRC form every 3 months to confirm your eligibility has not changed.
